They would be looking at other possible options instead, such as doing some type of forgivable loan. Consultant Graphenteen then asked the board if they would be interested in modifying the County RLF loan policies/guidelines so if needed/requested, the EDA would be able to possibly do something along the same line as the City of Eden Valley for Plymouth Industries. And if they are interested in modifying the policies/guidelines what would some of the possible parameters be? After discussing the board agreed to wait and see to how things play out with the Eden Valley Special Meeting and City Council meeting before doing anything with the County RLF Policies/Guidelines.

Consultant Graphenteen received a Housing Fund Loan request for four buildings in downtown Litchfield. The terms of the loan request were:

- Loan Amount of \$250,000
- Loan period 25 years
- Interest rate 0 %

After board discussion the board asked Consultant Graphenteen to counter the Housing Fund loan request with:

- Loan period of 15 years
- Interest rate 2% (negotiable)
